



## Carolyn E. Stephens

July 17, 1961 - March 31, 2024

Carolyn Ellen Stephens was born to George LeRoy & Dorothy Lee (Grubaugh) Romshek on July 17, 1961 at David City, Nebraska. She passed away on March 31, 2024 at the family cabin near Bellwood, Nebraska at the age of 62 years, 8 months and 14 days. She was one of 5 children born in the family.

Carolyn attended David City High School and graduated with the class of 1979. She went on to attend the University of Nebraska at Lincoln and Kearney. In 1984, she moved to Littleton, Colorado where she was a nanny for four years. She returned to David City in 1989 when her father became ill and she began working for David City Elementary School while working other part time jobs in the area. In 1992, she moved to Geneva, Nebraska and became a para-educator at Geneva Public School. She then began a 20-year career at the Youth Treatment and Rehabilitation Center (YRTC) as a cottage supervisor. In 2014, she moved over the Department of Motor Vehicles as a driver's license examiner and remained in this role until her death.

Carolyn was married to Brad Stephens of Geneva, Nebraska, on October 17, 1998. Two children were born to this union: Jordan and Jared.

Carolyn was a long-standing member of the United Methodist Church in Geneva. She served on various committees, was active in the choir, and was

currently Chair of the Church Council. The Church was an important part of Carolyn's life, and it brought her many lasting relationships with friends and acquaintances. Carolyn also loved to cook and bake, and she made sure she always brought pies for each niece and nephew anytime a holiday family gathering was held. She also loved her family dearly and especially enjoyed time at Jarecki Lake with everyone. Her endearing nature will be missed by all that knew her.

Carolyn was preceded in death by her parents, George & Dorothy; grandparents, George & Minnie Romshek, Sr. and Richard & Carol Grubaugh; father-in-law and mother-in-law, Merl & Hearldine Stephens; and brother, Dennis Romshek.

She is survived by her husband, Brad Stephens of Geneva, Nebraska; sons, Jordan Stephens and Jared Stephens & his special friend, Haley Korbelik all of Geneva, Nebraska; brother & sister-in-law, Dick & Ann Romshek of Elmwood, Nebraska; sister & brothers-in-law, Carmen & Kurt Johnson of Seward, Nebraska and Cathy & Eric Matulka of Lincoln, Nebraska; sister-in-law, Patti (Romshek) Meysenburg & husband Barry of David City, Nebraska; brothers-in-law Craig Stephens and Kim Stephens both of Crete, Nebraska; sister-in-law & brother in law Peg & Lee Gillen of Wichita, Kansas; nieces, nephews, great nieces, great nephews and several close friends.

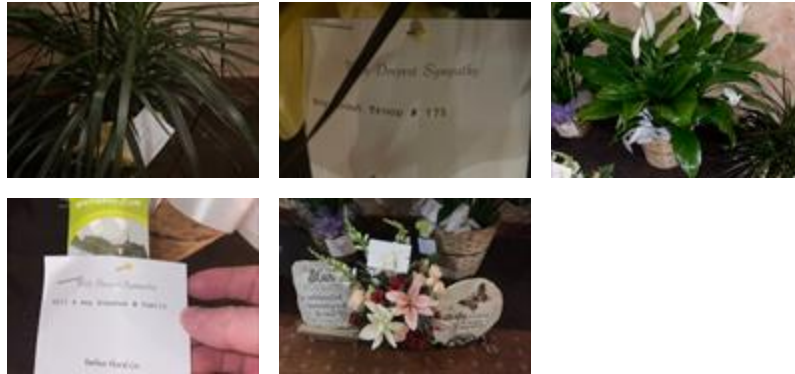
